PURPOSE OF POSITION

The Environmental Response Specialist (ERS) protects the environment and the public by providing authoritative and technical expertise on the management, assessment and remediation associated with spillage and discharges from oil and gas activities. This is achieved through administration and enforcement of the *OGAA*, the *EMA* and applicable regulations. Responsibilities also include the administration, assessment, and review of waste discharge applications under the *EMA* pertaining to oil and gas activities, including air emissions, solid and liquid wastes from drilling, completion, and production operations, as well as the collection of samples from environmental media and the operation and maintenance of environmental sampling equipment.

The ERS works through the Executive Director, Compliance & Enforcement to enhance systematic approaches, policies, and procedures to ensure consistent and appropriate management and documentation of spillage from oil and gas activities. The ERS also works to ensure and maintain coordinated approaches and interaction with other related agencies.

The BC Oil and Gas Commission (Commission) is the provincial single-window regulatory agency with responsibilities for regulating oil and gas operations in British Columbia, including exploration, development, pipeline transportation and reclamation.

The Commission's core roles include reviewing and assessing applications for industry activity, consulting with First Nations, ensuring industry complies with provincial legislation and cooperating with partner agencies. The public interest is protected through the objectives of ensuring public safety, protecting the environment, conserving petroleum resources and ensuring equitable participation in production.

JOB OVERVIEW

The Environmental Response Specialist (ERS) protects the environment and the public by providing authoritative and technical expertise on the management, assessment and remediation associated with spillage and discharges from oil and gas activities. This is achieved through administration and enforcement of the *OGAA*, the *EMA* and applicable regulations. Responsibilities also include the administration, assessment and review of waste discharge applications under the *EMA* pertaining to oil and gas activities, including air emissions, solid and liquid wastes from drilling, completion, and production operations, as well as the collection of samples from environmental media and the operation and maintenance of environmental sampling equipment. The ERS also works to ensure and maintain coordinated approaches and interaction with other related agencies.

ACCOUNTABILITIES

- Ensures consistent management and follow up to incident reports involving spills or releases;
- Conducts follow up investigation as required which may involve site visits to determine that the appropriate response actions were taken, and follow up at sites with longer term remediation issues;
- Gathers evidence for legal proceedings and testifying in court where required;
- Provides authoritative, technical direction to industry, environmental consultants, governments, staff, stakeholders
 and the public for acceptable waste management policy, legislation, handling, storage, disposal or discharge for the
 upstream oil and gas industry;
- Prepares technical recommendation and directions to the Executive Director, regarding issuance of determination
 and approvals based upon technical review and analysis of waste and terminal destination, impacts, preliminary and
 detailed site investigation reports, remediation plans and confirmation of remediation reports;
- Analyses applications for technical completeness, performing direct consultation with proponents, instructing on requirements of the OGC, advising on requirements of other regulatory agencies and governments;

- Develops and negotiates terms of reference with clients and QEP's to establish authorization and operational certificate discharge conditions to mitigate environmental impact;
- Negotiates with applicants for further studies, changes of additions to proposed waste treatment and storage facilities, including emergency measures and spill contingency plans;
- Prepares the discharge, or storage authorization documents and letters of transmittal specifying programs to be implemented and necessary security requirements on behalf of the section head;
- Prepares appeal response of permit and operational certificate conditions if appealed by applicants or affected partied and presents information to the Environmental Review Board on behalf of the Executive Director;
- Audits, or investigates non-compliance of a statutory authorizations, evaluates and characterizes environmental
 impacts and summarizes information in report form and determines the most effective method to mitigate
 environmental impacts of a non-compliance through technical assessment, negotiations and problem resolution;
- Reviews, assesses and provides technical advice and recommendations to environmental protection plans produced by QEP's;
- Provides technical assessment on reports submitted on environmental issues, identifies concerns of others (agencies, stakeholders and elected officials) resolving differences and formulating strategies on proposed discharges;
- Performs and supports environmental monitoring actions undertaken by the commission;
- Answers queries from and provides technical advice to, OGC headquarters staff, MOE, MEMPR, other government agencies, QEP's, the public and stakeholders regarding oil and gas field operations waste management;
- Plans, organizes and represents the Commission at technical seminars, stakeholder events, staff training and development opportunities;
- Maintains and updates a comprehensive knowledge of oil and gas field waste materials, water, well
 drilling/completion/workover fluids, gases, and other wastes as well as mitigative and remediation technologies
 through independent research and attending conferences, seminars and training courses;
